

## REGULATIONS AND TECHNICAL INFORMATION

### Corri Trieste 2023

### Competitive Road Race 10 KM

21 st May 2023

The A.S.D. Promorun Trieste, in collaboration with the Municipality of Trieste and the Friuli Venezia Giulia Region, is organizing the 20th edition of Corri Trieste, an athletics road race event included in the FIDAL National Calendar. The event will take place in all weather conditions.

The presence of a doctor and ambulance service will be guaranteed. The organizing company declines all responsibility for any damage to people or things that may occur before, during or after the event. For anything not provided for in these regulations, the FIDAL and G.G.G. federal regulations apply.

By registering for the race, the athlete declares that he has read and fully accepts these regulations.

### START

Sunday 21st May 2023 from Piazza Venezia

Meeting: 8:00 a.m. Piazza Venezia

Start: 9:00 a.m.

### REGISTRATIONS

**The maximum number of participants is 400 athletes between the competitive 10k race and Ten not competitive race. Online registrations will close on October 15, 2023 at 23:59 or upon reaching the maximum number of 400 registered.**

Online registrations with increasing fees:

from 1st November to 31th January 15,00 €

from 1st February to 31th March 18,00 €

from 1st April to 15th May 20,00 €

## **Not pre-registered**

It will be possible to register at the Corri Trieste registration center for the fee of € 25,00.

The location and times of the registration center will be announced through the social channels and on the official website of the event in the days before the event.

Registrations will not be accepted without the required documentation (see Participation requirements and privacy form on the website [www.corritrieste.it](http://www.corritrieste.it)), or with incomplete contact details and personal data.

## **THE FEE INCLUDES**

- Technical T-shirt
- Event bag
- Medal
- Sponsor products
- Medical assistance
- Timing service with chip to be returned at the end of the race. If the chip is not returned, the athlete must pay € 20 as compensation.
- Refreshments along the route
- Final refreshment

## **REFUNDS AND TRANSFERS**

Participation fees are not refundable and it is not possible to transfer the registration to another athlete.

## **ATHLETES RESIDING IN ITALY**

Based on the provisions of the rules for the organization of events issued by FIDAL, athletes resident in Italy, who have reached the age of 18 at the date of the event (20 years for Runcard members), belonging to the following categories, can participate :

Athletes registered for the current year for FIDAL affiliated clubs.

Athletes in possession of Runcard and a medical certificate of fitness for competitive athletics practice.

The card can be subscribed online on the website [www.runcard.com](http://www.runcard.com) .

Athletes registered with a Sports Promotion Body (Athletics Section) , in possession of Runcard-EPS and a medical certificate of fitness for competitive athletics .

## **ATHLETES NOT RESIDING IN ITALY**

Based on the provisions of the rules for the organization of events issued by FIDAL, athletes who are not resident in Italy who have reached the age of 18 at the date of the event (20 years for Runcard members) can participate, belonging to the following categories:

Athletes with club cards affiliated to Foreign Athletics Federations recognized by the IAAF.

Athletes in possession of Runcard (valid as sports insurance and permission to compete); and a medical certificate of suitability for competitive athletics practice.

The card can be subscribed online on the website [runcard.com](http://runcard.com).

For foreign athletes it is necessary to fill in the "Liability Waiver Form" to be able to participate in the event (to be sent during registration or delivered at the time of bib withdraw).

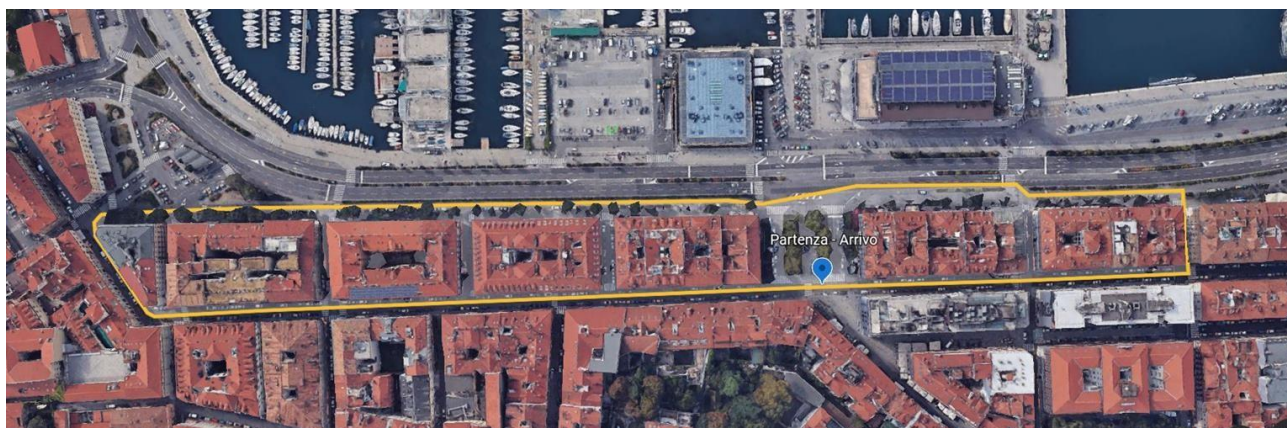
## **BIB AND RACE PACKAGE COLLECTION**

It will be possible to collect the race package at the Corri Trieste registration center.

The location and times of the registration center will be announced through the social channels and on the official website of the event in the days before the event.

In case of pick up by proxy, the delegator must fill in, sign and give to the delegate the proxy form, the privacy, a copy of the registration confirmation letter and a copy of his / her document identity.

## **ROUTE**



10 km by road; route completely closed to traffic with start and arrival from Piazza Venezia, with two very fast straights, one inside the center and the other seafront. 1,250m track to be repeated 8 times.

## **TIME LIMIT**

The time limit to complete the 10 km competitive race is 1h10', beyond this time limit the Organizing Committee will no longer guarantee control and assistance on the race route.

## **REFRESHMENTS**

As per Fidal regulations, there will be one refreshment point at km 5 and one in the finish area.

## **TIMING AND CLASSIFICATIONS**

The gun timing and the processing of the rankings are carried out by TDS (Timing Data Service) and are validated by the Technical Delegate Race Judge / Appeal Judge. The classifications will be available online on the TDS website on the event page. The publication of the classifications in the finish area is not foreseen. Complaints shall be lodged no later than 30 minutes after the online publication of the classifications.

## **BAG DEPOSIT**

There is no bag deposit. All athletes are invited to leave their bags inside their cars and to arrive in the starting area with competition clothing. It is absolutely forbidden to leave any clothing inside the start area or along the route.

## **INDIVIDUAL AWARDS**

The first 3 absolute male and female athletes and the first 3 classified in each master category will be awarded with prizes in kind.

Podium for the first 3 absolute men and women immediately after arrival.

**Unclaimed prizes can no longer be claimed.**

## **SOCIETY AWARDS**

Prizes in kind will be awarded to the first 5 companies classified with a minimum of 15 athletes on the basis of the number of athletes arriving at the finish line, the sum of the athletes arriving at the finish line will determine the final classification.

**Unclaimed prizes cannot be claimed again.**

## **ANTI-DOPING SERVICE**

Procedures according to FMSI - AIU - WADA indications.

## **COMPLAINTS**

Any complaints must be made in accordance with the FIDAL and R.T.I. regulations.

## **RIGHTS FOR IMAGE**

By registering for Corri Trieste 2023, the athlete authorizes the organization to acquire, free of charge, the right, together with its partners, to use the still or moving images on which he/she may appear, taken during his/her participation in Corri Trieste 2023, on all visual media as well as on promotional and/or advertising materials.

## **FRAUDULENT PARTICIPATION IN THE RACE – SANCTIONS**

The participant is responsible for the ownership and custody of his race bib, acquiring the right to use all the services mentioned in these regulations and subsequent communications.

1. Anyone who takes part in the race without a regular registration number will not only be held responsible for damage to persons or property, including himself, but will also incur sporting sanctions under the jurisdiction of the federal bodies and may be liable to the criminal sanctions provided for the crime of “theft” (art. 624 of the Italian Criminal Code).
2. Anyone who, without regular registration, takes part in the event with a counterfeit bib number or in any case one which does not conform to the allocation, as well as being liable as indicated above, will incur sporting sanctions and, in addition, may be liable to the criminal sanctions provided for the offence of “theft” (art. 624 of the criminal code), or, alternatively, for the offence of “fraud” (art. 640 of the criminal code).

In cases 1 and 2, participants may be liable to the penalties laid down for the offence of “failure to comply with the provisions of the authorities” (Article 650 of the criminal code). The above-mentioned cases will only be found after verification of photographic and/or video documentation.

## **FINAL WARNINGS**

The Organizing Committee reserves the right to modify these regulations at any time for reasons it deems appropriate for a better organization of the race, after having given notice and obtained approval from FIDAL. For anything not provided for in these regulations, the technical statutory regulations of the FIDAL and the G.G.G. apply. Any changes to services, places and times will be communicated to the registered athletes or will be posted on the website [www.promorun.it](http://www.promorun.it). In addition, the documentation containing the essential information to take part in the race will be delivered by the organization together with the bib.

## **RACE CANCELLATION - NON-EXECUTION**

If the race is cancelled, moved to another date and/or, in any case, not carried out due to causes that do not depend on and/or cannot be attributed to the will of the organization, including the withdrawal of the authorization to hold the race by the competent public bodies, weather events, earthquakes, epidemics and any other event that may jeopardize the safety of the participants, the participant will not be entitled to claim any reimbursement from the organizing company. Registrations received will be valid for the following year or for another Promorun event. The transfer will be completely free of charge.
